Release, Hold Harmless, and Indemnification Agreement

In exchange for admission to the Casper Skeet, Trap & Sporting Clays Club, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Participant agrees to the following:

1. Participant waives, for themselves and their executors, administrators, assignees or heirs, any and all rights and claims for damages, losses, demands and any other actions whatsoever individually or jointly and severally, which Participant may have or which may arise against the Casper Skeet, Trap & Sporting Clays Club or the City of Casper and any of their employees, directors, officers, or agents, including but not limited to any and all injuries, damages, or illnesses suffered by Participant and/or Participant's property, which may, in any way whatsoever, arise out of, be related to, or be connected with the course of instruction, the range, buildings, land and premises (hereinafter the "Premises"), including any latent defect in the Premises; Participant's presence on or use of said Premises, third party use of said Premises, Participant's property, and any escape of vapors, gases, lead or other particles including clay targets and/or shot pellets; any injury whatsoever to Participant; any and all claims arising out of the transfer, receipt, assembly, handling, use, discharge, maintenance or repair of any firearm or ammunition, any act or omission of Casper Skeet, Trap & Sporting Clays Club, its officers, directors or employees and the City of Casper. The Casper Skeet, Trap & Sporting Clays Club and the City of Casper shall not be liable for, and Participant on behalf of themselves and their executors, administrators, assignees, or heirs, hereby expressly release Casper Skeet, Trap & Sporting Clays Club and the City of Casper from any and all such claims **WHETHER OR NOT SUCH CLAIM(S) AROSE FROM THEIR NEGLIGENCE OR FROM ANY OTHER NON-WILLFUL CAUSE.**
2. Participant hereby expressly assumes the risk of entering the Premises and of taking part in activities on the Premises, which include, but are not limited to, the discharge of firearms and the firing of live ammunition. Participant acknowledges and understands that the activities of hunting, clay target shooting, and shotgun shooting have inherent risks, hazards and dangers that cannot be eliminated. Participant acknowledges that other shooting ranges are available for use in the surrounding area.
3. Participant agrees to indemnify, hold harmless and defend The Casper Skeet, Trap & Sporting Clays Club and the City of Casper from any and all fault, liabilities, costs, expenses, claims, demands, or lawsuits arising out of, related to or connected with the discharge of firearms, the course of instruction and the Premises resulting from or related to Participant's presence on or use of said Premises and should any such claim, demand, or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States, any State, or under any theory of law or equity, Participant will indemnify, hold harmless and defend The Casper Skeet, Trap & Sporting Clays Club and the City of Casper from any and all costs, expenses or liability including, individually, jointly or severally with Participant, together with all costs or court and other costs or expenses incurred in connection with any such claim, demand, or lawsuit, including attorney's fees.
4. **Participant furthermore hereby acknowledges and agrees that he/she has read, understands the Agreement and will at all times abide by this Agreement and all range rules and procedures.**

This instrument binds Participant and his executors, administrators, or heirs.
